Corporate Pass Guidelines

- Pass allows for ONE TIME per day use daily on either course
- Pass rounds and guest rounds may not be split up over multiple times daily
- Guest pricing only available when the guest accompanies the pass users
- Tee Times must be made by authorized Pass Representative
- Tee Times available 14 days in advance
- Range balls included for pass users and guests at the time of play only
- 15% off Pro Shop merchandise for purchases over \$25
- Corporate Groups eligible for special pricing when booked and paid by the pass holder.
- All credit card transactions will incur a 3% transaction fee

PLAYER PASS GUIDELINES

- *Playing privileges begin once your pass has been paid in full.*
- *Playing passes expire at the end of golf season (or December 31st, 2026).*
- *Golf Courses should open approx around April 1st, and close at a date TBD by mngmt.*
- *Golf Cart and Driving Range privileges are included in 2026 Corporate Passes.*
- *Pass holders may make tee times up to 14 days in advance.*
- *All Pass holders receive 15% off Pro Shop Merchandise on purchases over \$25.00.*
- *CORPORATE PASS DISCOUNT - Player Pass holders will receive room rental discounts on private events held at the Chestnut Ridge Club House. Event must be planned and paid by the Pass Holder, discount is not transferrable.*
- *All credit card transactions will incur a 3% transaction fee.*
